VACATION OF MOUNT ALIFAN PLACE.

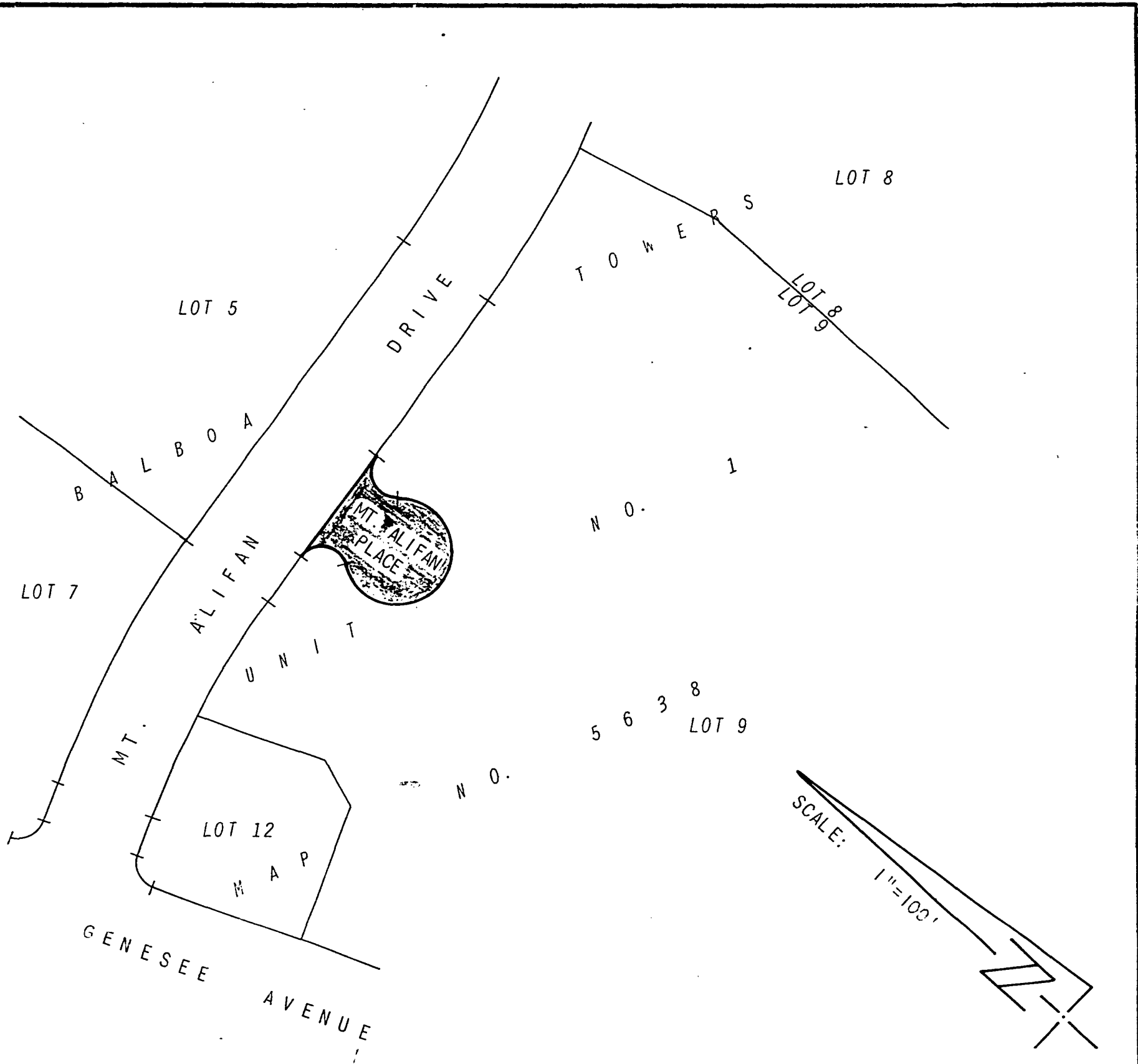


as more particularly referred to in Resolution of Intention No. 198660 is unnecessary for present or prospective public street purposes.
