

RESOLUTION NO. 198861

APPROVING MAP OF SUMMER HOUSE TRACT SUBDIVISION AND
ACCEPTING ON BEHALF OF THE PUBLIC PORTION OF PUBLIC
STREET DEDICATED ON SAID MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by O. B. SHOLDERS, Registered Civil Engineer, and entitled,
"SUMMER HOUSE TRACT Being a subdivision of Lot 9, Sycamore
Terrace, Map 2866, filed April 22, 1952, Lot 7 Dorado Terrace
subdivision, Map 3168, filed December 24, 1954, and portions
of Pueblo Lot 1286 of the Pueblo Lands, according to Map thereof
made by James Pascoe in 1870, a copy of which Map was filed
November 14, 1921 in the office of County Recorder of San Diego
County, and is known as Miscellaneous Map No. 36, all being in
the City of San Diego, County of San Diego, State of California.",
is made in the manner and form prescribed by law and conforms
to the surrounding surveys; that said map and the subdivision
of land shown thereon is hereby approved and accepted; and said
Council hereby accepts on behalf of the public, portion of a
public street, to wit: portion of Ardath Road, for public
purposes, and said portion of street is hereby declared to be
portion of public street and dedicated to the public use.

The Clerk of said City is hereby authorized and directed
to endorse upon said map, as and for the act of the Council,
that said Council has approved said subdivision map and that
said portion of public street is accepted on behalf of the
public as heretofore stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
