

RESOLUTION NO. 198872

WHEREAS, The City of San Diego is the owner of Lots 1 to 5, inclusive of Research Park Subdivision Addition, according to Map thereof No. 6386, filed June 12, 1969; and

WHEREAS, an agreement was made between the City and The Pacific Telephone and Telegraph Company whereby the City agreed to grant an easement to The Pacific Telephone and Telegraph Company for underground communication facilities in said Lots 1 to 5, inclusive of Research Park Subdivision Addition; and

WHEREAS, The Pacific Telephone and Telegraph Company constructed the underground communication facilities in said Lots 1 to 5, inclusive of Research Park Subdivision Addition, prior to obtaining an easement from the City in order to expedite the filing of the subdivision map; and

WHEREAS, the purposes for which the easement is required are public purposes; and

WHEREAS, Section 22.0907 of the San Diego Municipal Code authorizes the conveyance of City property to public agencies for public purposes without complying with the provisions relating to the advertising for bids and auction sales contained in the Municipal Code; and

WHEREAS, the City Manager, pursuant to Section 22.0907 of the San Diego Municipal Code, has recommended that said easement be conveyed to The Pacific Telephone and Telegraph Company, a corporation; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That, in consideration of the benefits to accrue to the people of said City, the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of, and as the act and deed

of, The City of San Diego, a deed of easement, conveying to THE PACIFIC TELEPHONE AND TELEGRAPH COMPANY, a corporation, an easement for underground communication facilities, upon, along and under portions of Lots 1 to 5, inclusive, of Research Park Subdivision Addition, as more particularly described in the form of deed, on file in the office of the City Clerk as Document No. 730582.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver said deed to the Property Director for further handling.
