RESOLUTION NO. 198876

RESOLUTION ORDERING WORK TO IMPROVE AND TO CHANGE THE GRADE ON ALLEY, BLOCK 24, NORMAL HEIGHTS; AND TO IMPROVE AND ESTABLISH THE GRADE ON ALLEY, BLOCK D, POINT LOMA HEIGHTS AND ALLEY, BLOCK 237, PACIFIC BEACH.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


1. That the public interest and convenience require the improvement herein referred to, and that this Council hereby orders that the work and improvement as described in Resolution of Intention No. 198502, passed and adopted by the City Council on NOV 25 1969, and the plans, profiles and specifications therein referred to, be done and made.

2. That the boundaries of the district to be assessed and the grades to which said work is to be done, shall be those described in said Resolution of Intention, and the plans, profiles and specifications therein referred to, reference to which is hereby made to all particulars.

3. The Purchasing Agent is hereby directed to post conspicuously for five (5) days, on or near the Council Chamber door in the manner and form required by law, the notice, together with a copy of the prevailing wage schedule established by Resolution No. 193707, inviting sealed proposals or bids for doing the work ordered; and the Purchasing Agent is hereby directed to publish twice in the City Official Newspaper a notice inviting such proposals for doing the work.
