

RESOLUTION No. 198887


Adopted on JAN 15 1970

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of GERTRUDE MICHELFELDER, formerly GERTRUDE ZIPPWALD; LILLIAN WEILAND; OTTO ZIPPWALD; DAISY DICKSON; JOHN ZIPPWALD; and JACK C. ZIPPWALD, executed in favor of The City of San Diego, bearing date March 13, 1969, conveying to said City Lots 3 and 4, Block 7, Paradise Valley Heights, being a subdivision of the Northwest Quarter of Quarter Section 77 of Rancho de la Nacion, according to Map No. 166, on file in the office of the County Recorder of San Diego County, as shown on Partition Map thereof, filed in the office of the County Clerk of San Diego County in an action entitled "Union Trust Company of San Diego, a corporation, v. Louis J. Beach, et al.," Defendants, Superior Court Case No. 37710, as more particularly described in said deed, valued at \$500 or more, as certified by the Property Director, be, and the same is hereby approved; and the lands therein conveyed as Parcels 1 and 2 are hereby set aside and dedicated as and for a public street and the same are hereby named PARADISE VALLEY ROAD.

That the City Clerk of said City is hereby authorized and directed to transmit the foregoing said deed to the Property Department for recording and further disposition.


