

RESOLUTION NO. 198902

APPROVING MAP OF FRIAR GARDENS SUBDIVISION AND

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by WILLIAM B. RICK, Registered Civil Engineer, and entitled,
"FRIAR GARDENS Being a subdivision of a portion of Lots 1, 2
and 3 of the Partition of Pueblo Lot 1104, in the City of San
Diego, County of San Diego, State of California.", is made in
the manner and form prescribed by law and conforms to the sur-
rounding surveys; that said map and the subdivision of land
shown thereon is hereby approved and accepted.


BE IT FURTHER RESOLVED, that said Council hereby accepts

the easements with the right of ingress and egress for the
construction and maintenance of water facilities as granted

for the construction and maintenance of water facilities as

poration, as above stated.
