

RESOLUTION NO. 198906

WHEREAS, The City of San Diego heretofore entered into an agreement with UNIVERSITY CITY, a corporation, 1150 Silverado, La Jolla, California, to construct certain improvements in UNIVERSITY CITY SERVICE STATION SITES subdivision, which agreement is filed in the office of the City Clerk as Document No. 706966; and

WHEREAS, in connection with the performance of said agreement Bond Nos. 02-40-08 and 02-40-09 were issued by Glens Falls Insurance Company of Glens Falls, New York; and

WHEREAS, subdivider has not complied with the terms and provisions of said agreement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That UNIVERSITY CITY, a corporation, is hereby DECLARED TO BE IN DEFAULT of the terms and conditions of the agreement filed in the office of the City Clerk as Document No. 706966 on December 28, 1966, relating to the improvement of UNIVERSITY CITY SERVICE STATION SITES subdivision; and

BE IT FURTHER RESOLVED, that the City Attorney shall cause notice of this declaration of default to be given to the said UNIVERSITY CITY, and to the said Glens Falls Insurance Company of Glens Falls, New York.

BE IT FURTHER RESOLVED, that the City Manager is authorized to complete, or cause to be completed, said public work and improvements in accordance with the terms of said agreement.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to forward a certified copy of this resolution to the County Recorder.
