

RESOLUTION NO. 198907

WHEREAS, The City of San Diego heretofore entered into an agreement with UNIVERSITY CITY, a corporation, 1150 Silverado, La Jolla, California, to construct certain improvements in UNIVERSITY HILLS UNIT NO. 7 subdivision, which agreement is filed in the office of the City Clerk as Document No. 689605; and

WHEREAS, in connection with the performance of said agreement Bond No. 33837 was issued by National Automobile and Casualty Insurance Co., Los Angeles, California; and

WHEREAS, subdivider has not complied with the terms and provisions of said agreement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That UNIVERSITY CITY, a corporation, is hereby DECLARED TO BE IN DEFAULT of the terms and conditions of the agreement filed in the office of the City Clerk as Document No. 689605 on August 20, 1965, relating to the improvement of UNIVERSITY HILLS UNIT NO. 7 subdivision; and

BE IT FURTHER RESOLVED, that the City Attorney shall cause notice of this declaration of default to be given to the said UNIVERSITY CITY, and to the said National Automobile and Casualty Insurance Co., Los Angeles, California.

BE IT FURTHER RESOLVED, that the City Manager is authorized to complete, or cause to be completed, said public work and improvements in accordance with the terms of said agreement.

BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to forward a certified copy of this resolution to the County Recorder.
