

RESOLUTION NO. 198913

WHEREAS, in response to the Council's direction, the City Manager organized a Task Force composed of representatives from the City's Community Development, Planning, Engineering, Property and Building Inspection Departments and the City Attorney to undertake a study and recommend action for the expansion of Horton Plaza; and

WHEREAS, the Task Force carried out an intensive survey of the effect of the expansion of Horton Plaza in a 12-square-block area in terms of costs and financing; and

WHEREAS, the findings and conclusions of the Task Force were reported at the Council Conference of December 30, 1969; and

WHEREAS, the Task Force recommended that the Manager, Planning Director and Attorney be directed to make an in-depth study of the 12-square-block area surrounding Horton Plaza and make specific recommendations within eight months, including plans for land acquisition and disposition, relocation, property management, site preparation, financing, administration and development; and

WHEREAS, the Task Force further recommended that in order to carry out this in-depth study, \$25,000 be appropriated from the Unallocated Reserve for consulting services in connection with a market and financial feasibility study with architectural services as may be necessary for the proposed Horton Plaza expansion; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager, Planning Director and City Attorney are hereby directed to make an in-depth study of the 12-square-block area surrounding Horton Plaza and make specific recommendations within eight months for the area's redevelopment including plans for land acquisition, disposition, relocation, property management, site preparation, financing, administration and development.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer the sum of \$25,000 from the Unallocated Reserve (53.30) to Professional Services (43.00), solely and exclusively for the purpose of providing funds for consulting services incurred in said study.
