VACATION OF ALBA COURT AND STREET RESERVATION.

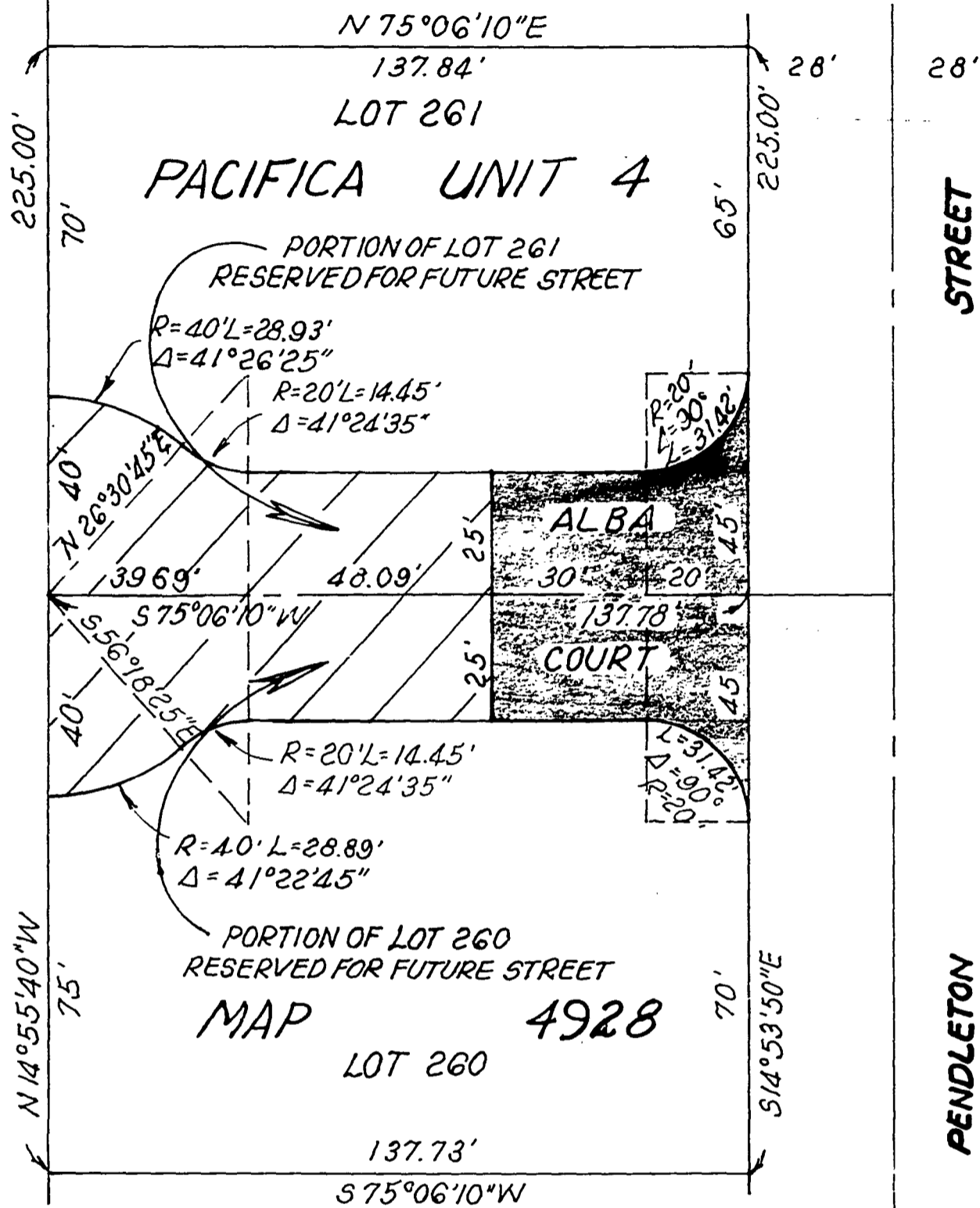


