

RESOLUTION NO. 198936

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Pursuant to authority conferred by and in accordance
with the provisions of Section 82.19 of the San Diego Muni-
cipal Code, the following streets in said City be, and they
are hereby declared to be ONE-WAY STREETS:

40TH STREET, between Ocean View Boulevard and
"T" Street, for one-way southerly-bound
traffic; and

BOUNDARY STREET, between "T" Street and Ocean
View Boulevard, for one-way northerly-
bound traffic.

BE IT FURTHER RESOLVED, that the installation of the
necessary signs and markings be, and the same are hereby
authorized to be made on said streets, and that the regu-
lations hereinabove imposed shall become effective upon the
installation of such signs.
