| Ben B. Bowers | PUBLIC WORKS DEPARTMENT Bldgs. & Elec. Division | \$300 | This is an additional award based on the 12-month review which shows that \$3,000 additional savings were made in the first year the suggestion was in use. A \$350 award was made originally. |
| Robert W. Norton | UTILITIES DEPARTMENT | \$10 | Proposed installing an unused pressure recorder in the central control room to read the sludge line pressures. This has been done to eliminate five daily trips to the lower level. Better control of pressure can be maintained which can reduce damage to sludge line. |
| Margaret A. Watson | PERSONNEL DEPARTMENT | \$50 | Combined forms and simplified procedure for making medical examination appointments and handling the results. Saves a substantial amount of time and improves service. Health Department work also reduced. |
