

RESOLUTION NO. 198940

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That an easement for the purpose of a right of way for
a public street (roadway) and incidents thereto, through, over,
under, along and across the hereinafter described property be,
and the same is hereby set aside and dedicated as and for a
public street and the same is hereby named GOVERNOR DRIVE:

All that portion of Pueblo Lands of San Diego,
in the City of San Diego, County of San Diego,
State of California, according to Map thereof
made by James Pascoe in 1870, a copy of which
said Map was filed in the office of the County
Recorder of San Diego County on November 14,
1921 as Miscellaneous Map No. 36, more particu-
larly described as follows:

Commencing at the Northeast corner of Lot 3,
University City Unit No. 9, according to Map
thereof No. 5100, filed in the office of the
County Recorder of San Diego County on
December 21, 1962, thence North 17°19'50" West,
a distance of 44.05 feet; thence South 70°00'00"
West, a distance of 404.62 feet to a point, said
point being the TRUE POINT OF BEGINNING; thence
North 20°00'00" West, a distance of 44.00 feet;
thence North 70°00'00" East, a distance of
399.24 feet to the beginning of a 956.00 foot
radius curve concave Northwesterly, a radial to
said point bears South 20°00'00" East; thence
Northeasterly along the arc of said curve
through a central angle of 29°27'54", an arc
length of 491.63 feet; thence North 40°32'06"
East, a distance of 1060.74 feet; thence North
38°31'49" East, a distance of 200.12 feet; thence
South 49°27'54" East, a distance of 102.00 feet;
thence South 42°32'22" West, a distance of
200.12 feet; thence South 40°32'06" West, a dis-
tance of 1060.74 feet to the beginning of a
1044.00 foot radius curve concave Northwesterly,
a radial to said point bears South 49°27'54"
East; thence Southwesterly along the arc of said

curve through a central angle of 01°25'32"
an arc length of 25.98 feet; thence North
50°00'00" West, a distance of 64.01 feet
to a point, said point being the beginning of
a 1000.00 foot radius curve concave North-
westerly, a radial to said point bears South
50°00'00" East; thence Southwesterly and
Westerly along the arc of said curve through
a central angle of 30°00'00", an arc length
of 523.60 feet; thence South 70°00'00" West
358.00 feet, returning to the TRUE POINT OF
BEGINNING.

BE IT FURTHER RESOLVED, that the City Clerk of said City
be, and he is hereby authorized and directed to record said
resolution in the office of the San Diego County Recorder.
