Said Council hereby finds that that certain map surveyed by CHARLES W. CHRISTENSEN, Registered Civil Engineer, and entitled, "SAN CARLOS UNIT NO. 9 RESUB NO. 2 Being a subdivision of Lots 659, 660, 661, 662, 663, 664, 665, 666, 667, 668, 669, 670, 671, and 672 of San Carlos Unit No. 9 in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 4890, filed in the office of the County Recorder of San Diego County, December 28, 1961.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, portion of a public street, to wit: a portion of Cowles Mountain Court for public purposes and said portion of a street is hereby declared to be a portion of a public street and dedicated to the public use.
