THAT A FINDING BE, AND IT IS HEREBY MADE, That a drive-thru restaurant, proposed to be located in the RC-1A zone on Lot 12, Balboa Towers Unit No. 1 located at the southeast corner of the intersection of Genesee Avenue and Mt. Alifan Drive, by Foodmaker, Inc., is not an enterprise similar to and is more obnoxious or detrimental to the welfare of the particular community than those enterprises or businesses permitted in Section 101.0425, San Diego Municipal Code.
