

RESOLUTION NO. 199053

WHEREAS, The City of San Diego on March 21, 1967 by Resolution No. 189837 authorized the employment of the firm of Dilworth, Paxson, Kalish, Kohn & Levy for the purposes of preparing and litigating the City's claim against certain brass and copper tubing manufacturers for violation of the antitrust laws; and

WHEREAS, The City of San Diego on May 18, 1967 by Resolution No. 190436 authorized a partial settlement with certain brass and copper tubing manufacturers; and

WHEREAS, the United States District Court for the Eastern District of Pennsylvania has heretofore approved a full settlement of all claims in that action known as the Western Brass Mill Tube and Pipe Case; and

WHEREAS, that court has approved an initial disbursement to all claimants, including \$16,414.70 to The City of San Diego; and

WHEREAS, subsequent distributions will be made on order of the United States District Court for the Eastern District of Pennsylvania; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That The City of San Diego hereby accepts that initial distribution of \$16,414.70 as approved by the United States District Court for the Eastern District of Pennsylvania.

BE IT FURTHER RESOLVED, that The City of San Diego hereby gives its assent to such future distributions as authorized by the United States District Court for the Eastern District of Pennsylvania.
