2. That the expenditure of \$135,000.00 is hereby authorized out of Park and Recreation Bond Fund (725) of the City of San Diego solely and exclusively for the purpose of providing funds for the Improvement of Serra Mesa Park and Recreation Center in the City of San Diego, and related costs.
