1. That the bid of \$64,948.35 by T. B. Penick & Sons, Inc., A Corporation, for the Improvement of Mission Hills Park, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the Specifications on file in the office of the City Clerk as Document Number 730317.

2. That the expenditure of \$80,000.00 is hereby authorized out of the Park and Recreation Fund (725) and \$5,100.00 is hereby authorized out of the Capital Outlay Fund (245), of the City of San Diego solely and exclusively for the purpose of providing funds for the Improvement of Mission Hills Park in the City of San Diego, California, and related costs.
