RESOLUTION NO. 199084

RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AWARDING A CONTRACT TO IMPROVE AND TO ESTABLISH THE GRADE ON ALLEY IN LA JOLLA VISTA SUBDIVISION, BETWEEN SPINDRIFT DRIVE AND VIKING WAY; ALLEY, BLOCK 1, STERLING PARK; ALLEY, BLOCK 105, PACIFIC BEACH; ALLEY IN PICARD TERRACE AND IN ACRE LOT 50, PACIFIC BEACH.


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

The City Clerk is hereby directed to cause notice of this award to be published twice in the City Official Newspaper and to record notice of this award in the office of the County Recorder as provided in Section 5248 of the Streets and Highways Code.
