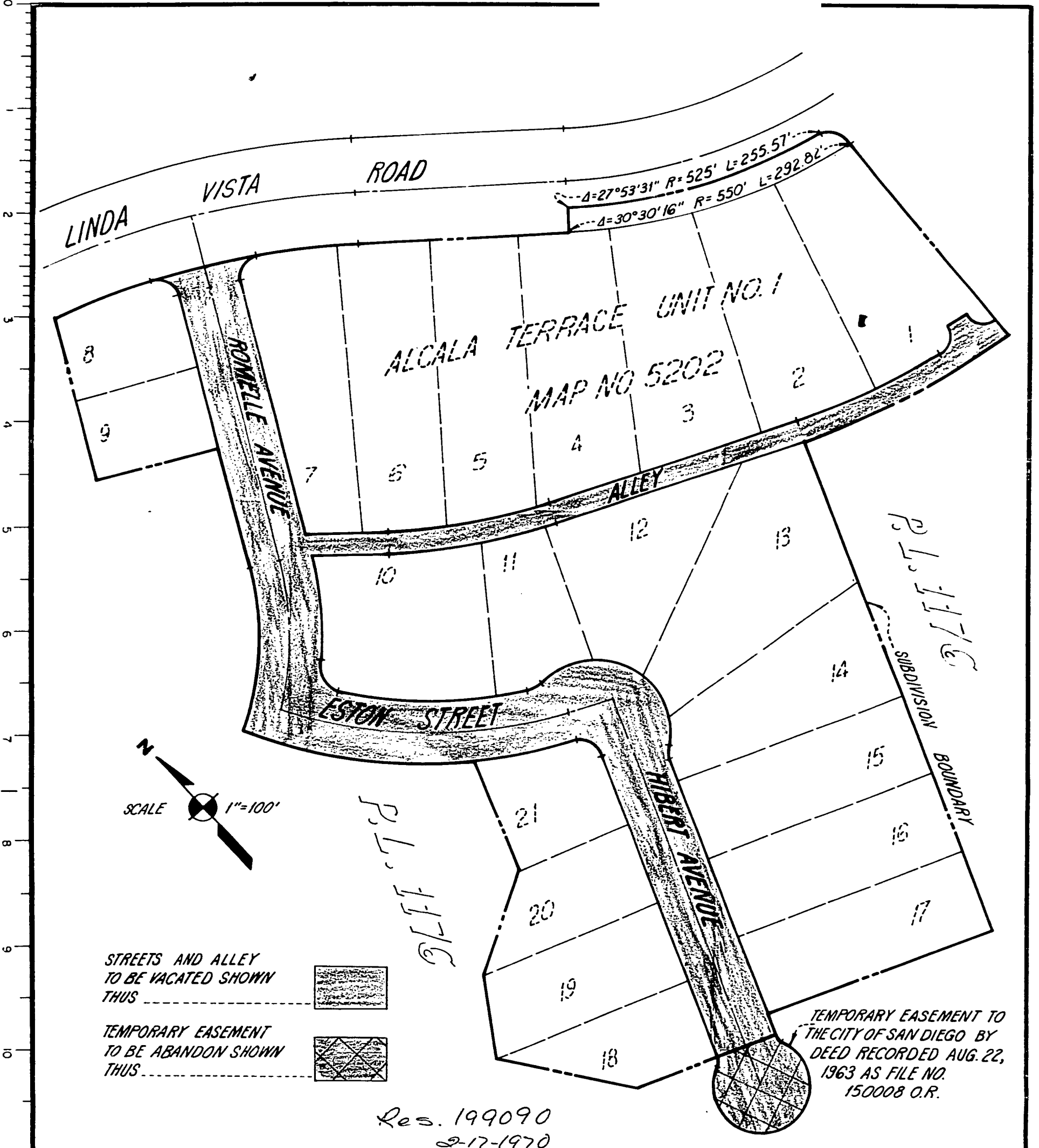
BE IT RESOLVED, By the Council of The City of San Diego, California, that ROMELLE AVENUE adjoining Lots 7-10; ESTON STREET adjoining Lots 10-12 and 21; HIBERT AVENUE adjoining Lots 13-21, all in and adjacent to Alcala Terrace Unit No. 1, and the ALLEY located between Romelle Avenue and the easterly boundary of the subdivision adjoining Lots 1-7 and 10-13 inclusive, Alcala Terrace Unit No. 1,


as more particularly referred to in Resolution of Intention No. 198740 is unnecessary for present or prospective public street purposes.

as more particularly shown on Map No. 11930-B, on file in the office of the City Clerk as Document No. 730414, which said map is attached hereto, marked Exhibit A and made a part hereof, be and the same is hereby ordered vacated.





STREETS AND ALLEY TO BE VACATED SHOWN THUS
