BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with DEEMS, LEWIS, MARTIN & ASSOCIATES for architectural services in connection with the project to construct a semi-mall on C STREET between Third and Eighth Avenues, and on FIFTH AVENUE between Broadway and B Streets, in the City of San Diego, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 730931.

BE IT FURTHER RESOLVED, that the expenditure of \$60,000 is hereby authorized out of Capital Outlay Fund 245 of The City of San Diego, solely and exclusively for the purpose of providing funds for the above project and supplementing Resolution No. 197830, in this amount.
