BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an amendment to an agreement with the SAN DIEGO CONVENTION AND VISITORS' BUREAU, a nonprofit California corporation, to provide an additional \$7,700 for the purpose of assisting in publishing a Sunday supplement of six million copies promoting San Diego as a convention and visitor site, under the terms and conditions set forth in the form of amendment to agreement on file in the office of the City Clerk as Document No. 730946.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer the sum of \$7,700 within the Transient Occupancy Fund, 223, from Promotion Contingency Reserve (52.29) to San Diego Convention and Visitors Bureau Winter Visitor Promotion Program (52.02) for the Sunday supplement described above.
