

RESOLUTION NO. 199125

APPROVING MAP OF BILL BEATY SUBDIVISION AND ACCEPTING ON BEHALF OF THE PUBLIC PORTION OF PUBLIC STREET DEDICATED ON SAID MAP, AND REJECTING THE OFFER OF DEDICATION FOR PUBLIC USE THAT PORTION OF LOT 1 MARKED "RESERVED FOR FUTURE STREET" AS SHOWN ON THIS MAP.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by W.D. HARGUS, Registered Civil Engineer, and entitled, "BILL BEATY Being a subdivision of Parcel 8, Nestor, L S Map No. 90 filed in the office of the San Diego County Recorder, April 22, 1896.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the portion of public street, to wit: portion of Hollister Street, for public purposes, and said portion of street is hereby declared to be portion of public street and dedicated to the public use.


BE IT FURTHER RESOLVED, that said Council rejects as a dedication for public street that portion of Lot 1 marked "Reserved for Future Street" as shown on this map, under the provisions of Section 11616 of the Business and Professions Code.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of public street is accepted on behalf of the public as heretofore stated; and said Council has rejected on behalf of the public that portion of Lot 1 marked "Reserved for Future Street" shown on this map within this subdivision, all as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
