the north line of Lot 8, Nestor,

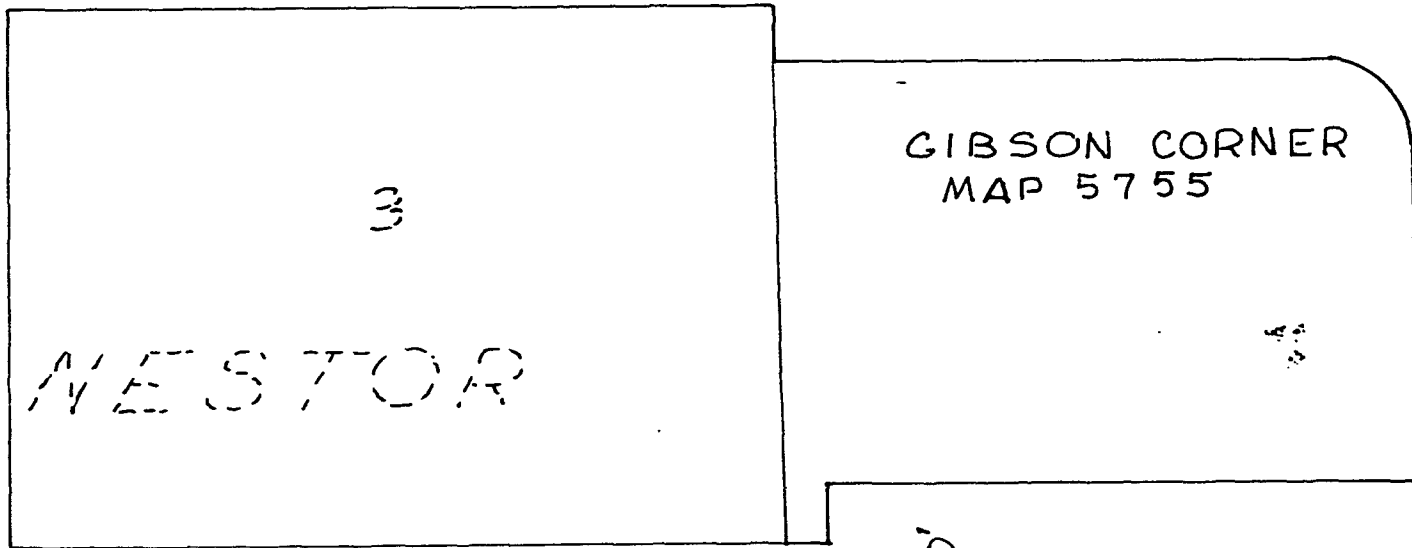
as more particularly referred to in Resolution of Intention

line of Flower Avenue and the north line of Lot 8, Nestor,

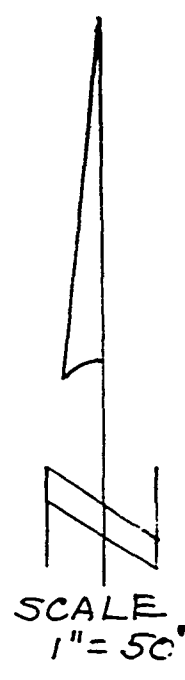
as more particularly shown on Map No. 12004-B, on file in the

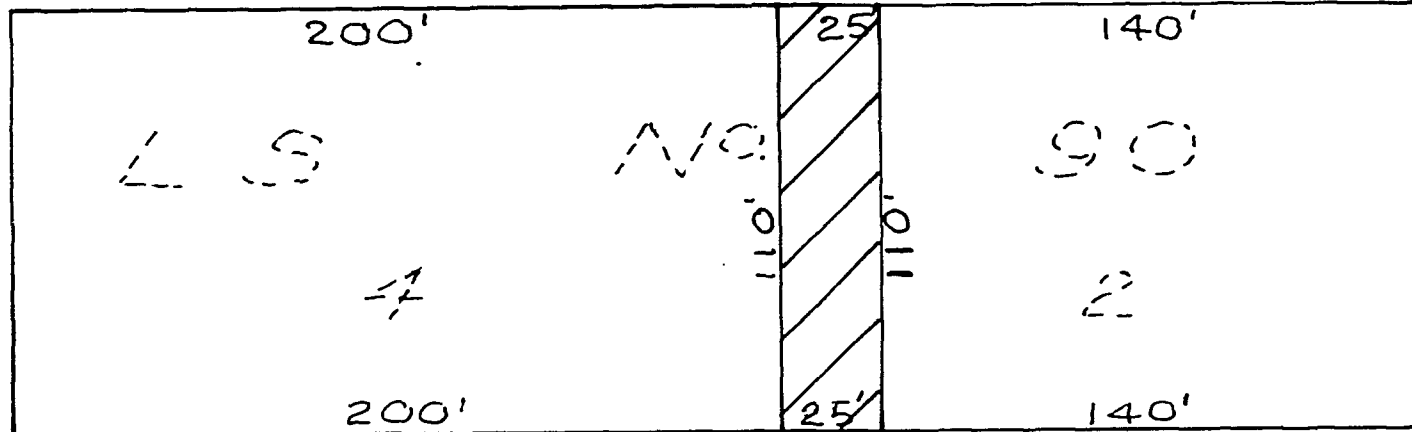
