

RESOLUTION NO. 199176

WHEREAS, the United States of America has heretofore made an advance, pursuant to an agreement dated December 1, 1946 and entitled Calif-4-P-497 to The City of San Diego in the amount of \$15,200 for the purpose of preparing plans to convert the "Federal Building" in Balboa Park into a civic theater; and

WHEREAS, The City of San Diego has expended those Federal funds advanced for the preparation of plans and specifications for the public work described in the aforementioned agreement; and

WHEREAS, a substitute facility has been constructed and it has been determined that no part of the plans prepared with the Federal advance was of value or could have been used in the construction of said substitute facility; and

WHEREAS, it is the desire of The City of San Diego to be relieved of any liability or obligations incurred pursuant to the aforementioned agreement, Calif-4-P-497; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Housing and Home Finance Administrator is hereby requested to make a determination that The City of San Diego be relieved of all liability under that grant contract dated December 1, 1946 and entitled Calif-4-P-497.

2. That the City Manager is hereby authorized, empowered and directed to submit this resolution along

with those notarized statements, copies of which are on file in the office of the City Clerk as Document No. 731050, certifying that the plans prepared for the construction of the San Diego Convention Hall, Community Concourse and Civic Theater were not based in any way on plans developed under the 1946 grant entitled Calif-4-P-497 to the United States Department of Housing and Urban Development.
