

RESOLUTION NO. 199187

APPROVING MAP OF AMHERST ESTATES SUBDIVISION AND
ACCEPTING ON BEHALF OF THE PUBLIC PORTION OF
PUBLIC STREET DEDICATED ON SAID MAP WITHIN THIS
SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by
RAYMOND F. HALL, JR., Registered Civil Engineer, and entitled,
"AMHERST ESTATES Being a subdivision of portions of Lots "C"
and "H" of La Mesa Colony, Map 346, filed March 8, 1887 in the
office of the County Recorder of San Diego County, State of Cali-
fornia, and portion of Amherst Street (Ramona Street) vacated
April 3, 1923, Document No. 16749 Book 751, Page 309 of Deeds
filed in the office of said County Recorder, all being in the
City of San Diego, County of San Diego, State of California.",
is made in the manner and form prescribed by law and conforms to
the surrounding surveys; that said map and the subdivision of land
shown thereon is hereby approved and accepted; and said Council
hereby accepts on behalf of the public, portion of a public street,
to wit: portion of 67th Street, for public purposes, and said
portion of street is hereby declared to be portion of public
street and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to
endorse upon said map, as and for the act of the Council, that
said Council has approved said subdivision map and that said
portion of public street is accepted on behalf of the public as
heretofore stated.

Said City Clerk is hereby directed to transmit said map to
the Clerk of the Board of Supervisors of the County of San Diego,
California.
