

RESOLUTION NO. 199189

APPROVING MAP OF LARWIN MESA VIEW UNIT NO. 1 SUB-DIVISION AND ACCEPTING ON BEHALF OF THE PUBLIC THE PUBLIC STREETS AND PORTION OF PUBLIC STREET DEDICATED ON SAID MAP, AND ACCEPTING ON BEHALF OF THE CITY OF SAN DIEGO, THE EASEMENT GRANTED ON THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by GARY L. McCABE, Registered Civil Engineer, and entitled, "LARWIN MESA VIEW UNIT NO. 1 Being a subdivision of portions of the Southeast quarter of the Southwest quarter of Section 30, the Northwest quarter of the Northeast quarter and the Northeast quarter of the Northwest quarter of Section 31, Township 14 South, Range 2 West, San Bernardino Meridian, in the City of San Diego, in the County of San Diego, State of California, according to United States Government survey, approved August 29, 1890.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public streets and portion of public street, to wit: Gemini Avenue, Black Mountain Road, Lyra Court, Pegasus Avenue, Jeffrey Court, Janice Court, Draco Road and a portion of Mira Mesa Boulevard, for public purposes, and said streets and portion of street are hereby declared to be public streets and portion of public street and dedicated to the public use.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement, with the right of ingress and egress for the construction and maintenance of drainage facilities, as granted and shown on said map, and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portion of public street are accepted on behalf of the public as heretofore stated; and that that certain easement with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on this map within this subdivision, is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
