

RESOLUTION NO. 199230

WHEREAS, Gretta Adele Hunt has, by affidavit of February 5, 1970, stated that the coupons on Bonds 2, 3 and 4, Series 3185, City of San Diego 1911 Act Improvement Bonds dated July 2, 1965, have become lost, misplaced, stolen or destroyed; and

WHEREAS, there is no cost to issue new bond coupons; and

WHEREAS, Section 6466, California Streets and Highways Code, provides that Sections 53460 et seq., California Government Code, shall apply in connection with lost or destroyed bonds; and

WHEREAS, Gretta Adele Hunt, Executrix of the Estate of Victor C. Hunt, has provided a Lost Securities Bond No. 40-0160-65-70 issued by the United States Fidelity and Guaranty Co., holding the City harmless against any and all costs; and


WHEREAS, this Council is satisfied that the coupons on Bonds 2, 3 and 4, Series 3185, City of San Diego 1911 Act Improvement Bonds dated July 2, 1965, have been lost; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Treasurer is hereby authorized to issue new coupons for Bonds 2, 3 and 4, Series 3185, City of San Diego 1911 Act Improvement Bonds bearing the date of July 2, 1965 to replace those lost, misplaced, stolen or destroyed.

That the City Treasurer place in his files the affidavit of Gretta Adele Hunt and the bond written by United States Fidelity and Guaranty Co.
