


RESOLUTION No. 199239

1. That the bid of \$113,691.00 by Kenneth H. Golden Co., for the CONSTRUCTION OF "C" STREET INTERCEPTOR SEWER - PHASE I in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the Specifications on file in the office of the City Clerk as Document No. 730648.
2. That the expenditure of \$130,000.00 is hereby authorized out of the Sewer Revenue Fund (506) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF "C" STREET INTERCEPTOR SEWER - PHASE I in the City of San Diego, and related costs.


