1. That the bid of \$2,948,388.00 by Nielsen Construction Company, A Corporation, for the CONSTRUCTION OF CULTURAL ACTIVITIES CENTER including ADDITIVE ALTERNATE NO. 1, and ADDITIVE ALTERNATE NO. 2, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the Specifications on file in the office of the City Clerk as Document Number 730363
  
2. That the expenditure of \$2,986,276.00 is hereby authorized out of the Balboa Park Facilities Bond Fund (729) of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF CULTURAL ACTIVITIES CENTER including ADDITIVE ALTERNATE NO. 1, and ADDITIVE ALTERNATE NO. 2, in the City of San Diego, California, and related costs.
