

RESOLUTION NO. 199306

WHEREAS, the Planning Commission of The City of San Diego has submitted a report and has recommended the annexation of that certain inhabited area known as MISSION SAN DIEGO DE ALCALA TRACT NO. 1 ANNEXATION; and

WHEREAS, the City Council has adopted Resolution No. 198824 approving circulation of a petition concerning said annexation; and

WHEREAS, due to the inclusion in the annexation of certain uninhabited land it is necessary to amend the annexation boundary to exclude said uninhabited land; and

WHEREAS, it is necessary to refer the annexation to the Local Agency Formation Commission for approval of the boundary change prior to action on the annexation by the City; and

WHEREAS, the revised boundary of the annexation will include land in a single ownership which would not require an election; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Resolution No. 198824 is hereby rescinded.

The revised boundary for MISSION SAN DIEGO DE ALCALA TRACT NO. 1 ANNEXATION is hereby referred to the Local Agency Formation Commission for consideration by that Commission.

The Local Agency Formation Commission is requested to consider the advisability of this annexation being considered a unanimous consent annexation which would not require an election, pursuant to Government Code Section 54797.1.
