BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by CHARLES W. CHRISTENSEN, Registered Civil Engineer, and entitled, "BERNARDO GREENS UNIT NO. 21 RESUB NO. 1 Being a subdivision of a portion of Rancho San Bernardo, according to Map thereof recorded in Book 2, Page 462 of Patents, and all of Lots 1790 through 1797 of Bernardo Greens Unit No. 21, and portions of Frondoso Drive and Pomerado Road now vacated, being in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 6349, filed in the office of County Recorder of San Diego County, May 1, 1969.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, a portion of a public street, to wit: a portion of Pomerado Road, for public purposes; and said portion of street is hereby declared to be a portion of a public street and dedicated to the public use.

abutters' rights of access in and to Pomerado Road, adjacent and contiguous to Lots 1983 through 1987, all as granted and shown on said map.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of a public street is accepted on behalf of the public as heretofore stated; and that those certain abutters' rights of access, together with easements with the right of ingress and egress for the construction and maintenance of sewer and water facilities as granted and shown on this map within this subdivision, are accepted on behalf of THE CITY OF SAN DIEGO, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
