BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by O.B. SHOLDERS, Registered Civil Engineer, and entitled, "VIA SORRENTO VALLEY INDUSTRIAL PARK UNIT NO. 4 Being a subdivision of a portion of the town of Sorrento, in the City of San Diego, County of San Diego, State of California, according to Maps thereof Nos. 362 and 483, filed in the office of County Recorder of San Diego County September 30, 1887, and February 9, 1888, respectively.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the public streets and portion of public street, to wit: Sorrento Valley Boulevard, Sorrento Valley Court and a portion of Sorrento Valley Road, for public purposes, and said streets and portion of street are hereby declared to be public streets and portion of public street and dedicated to the public use.

behalf of the public as heretofore stated; and that that certain easement with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on this map within this subdivision, is accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
