


RESOLUTION NO. 199343

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That the City Manager be and he is hereby authorized to accept the proposal of The Pacific Telephone and Telegraph Company to furnish, install and maintain a 520C Telephone Emergency Reporting System for The City of San Diego Fire Department, all as more particularly set forth in a letter from The Pacific Telephone and Telegraph Company dated January 9, 1970 (a copy of which is on file in the office of the City Clerk as Document No. 731324), the charges and costs for which are established by certain tariff schedules of The Pacific Telephone and Telegraph Company which have been approved by the California Public Utilities (copies of which are on file in the office of the City Clerk as Documents Nos. 731325, 731326, 731327, 731328 and 731329, and to execute an agreement therefor, the form of which is on file in the office of the City Clerk as Document No. 731330.

BE IT FURTHER RESOLVED, that the expenditure of \$122,928.00 is hereby authorized out of Capital Outlay Fund 245 of The City of San Diego, solely and exclusively for the purpose of providing funds for said system.
