Jesse Scott	PUBLIC WORKS DEPARTMENT Sanitation Division	\$40	Suggested welding the hooks for bags in trash containers on City streets. This will save considerable time when emptying bags. It will also save the cost and time for replacing many lost hooks.
Jack Dickens	PUBLIC WORKS DEPARTMENT Equipment Division	\$20	Designed a braking system for wreckers when towing packer trucks. This worked well but was too costly. This led to a new policy of having commercial wreckers tow packers to the repair shop. This is a safety suggestion.
Jack Dickens	PUBLIC WORKS DEPARTMENT Equipment Division	\$15	Suggester found that one line of trucks had the wrong dip sticks for measuring the oil level. These have been replaced by the manufacturer at no cost and this will save about 300 gallons of oil per year.
