

RESOLUTION NO. 199353

WHEREAS, heretofore by deed recorded April 11, 1958, as Document No. 58330 in Book 7033, page 265, of Official Records of the San Diego County Recorder, The City of San Diego acquired an easement for drainage purposes affecting a portion of Lot 183 of South Rancho Hills Unit No. 7; and

WHEREAS, a portion of said easement has never been used for the purpose for which it was acquired and more than one (1) year has elapsed since the date said easement was acquired; and

WHEREAS, a portion of said easement as hereinafter described is unnecessary for present or prospective public use by the City, and the City Manager recommends that the City vacate its interest therein; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That, pursuant to Section 50443 of the Government Code of the State of California, the drainage easement more particularly described hereinafter is hereby vacated:

All that portion of that certain drainage easement granted to The City of San Diego, by deed recorded April 11, 1958, as Document No. 58330, in Book 7033, page 265, of Official Records of the San Diego County Recorder, affecting the following described property:

Lot 183 of South Rancho Hills Unit No. 7, according to Map thereof No. 4512, filed April 15, 1960, in the office of the San Diego County Recorder.

That from and after the date of this order of vacation, title to the land previously subject to said drainage easement shall revert to the owner of the land free from the rights of the public.

BE IT FURTHER RESOLVED, that the City Clerk of said

City be, and he is hereby authorized and directed to cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder of said County of San Diego.
