

RESOLUTION NO. 199354

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

That an easement for the purpose of a right of way for
a public street (roadway) and incidents thereto, through, over,
under, along and across the hereinafter described property, be,
and the same is hereby set aside and dedicated as and for a
public street and the same is hereby named SORRENTO VALLEY
BOULEVARD:

That portion of Pueblo Lot 1355 of the Pueblo
Lands of San Diego, in the City of San Diego,
County of San Diego, State of California,
according to Map thereof made by James Pascoe
in 1870, a copy of which Map was filed in the
office of the County Recorder of said County
of San Diego, November 14, 1921 as Miscellaneous
Map No. 36, more particularly described as
follows:

Commencing at the most Northerly corner of said
Pueblo Lot 1355; thence South $46^{\circ}31'32''$ East
along the Easterly boundary of said Pueblo Lot
a distance of 185.58 feet to the TRUE POINT OF
BEGINNING; thence South $84^{\circ}44'28''$ West a distance
of 98.01 feet; thence South $15^{\circ}10'43''$ East along
the Westerly boundary of said Pueblo Lot a
distance of 89.34 feet; thence North $84^{\circ}44'28''$
East a distance of 91.37 feet to the beginning
of a 1,094.00 foot radius curve, concave Northerly;
thence Easterly along the arc of said curve,
through a central angle of $03^{\circ}29'39''$, an arc
length of 66.72 feet to a point of intersection in
the Easterly boundary of said Pueblo Lot; thence
North $46^{\circ}31'32''$ West a distance of 114.37 feet,
returning to the TRUE POINT OF BEGINNING.

BE IT FURTHER RESOLVED, that the City Clerk of said City,
be, and he is hereby authorized and directed to record said
resolution concurrently with the recording of said subdivision
map of Via Sorrento Valley Industrial Park, Unit No. 4.
