

RESOLUTION NO. 199368

APPROVING MAP OF EMERALD RIVIERA SUBDIVISION AND ACCEPTING ON BEHALF OF THE PUBLIC THE PUBLIC STREETS AND PORTION OF PUBLIC STREET DEDICATED ON SAID MAP, AND REJECTING THE OFFER OF DEDICATION FOR PUBLIC USE THOSE PORTIONS MARKED "RESERVED FOR FUTURE STREET," ALL AS SHOWN ON THIS MAP WITHIN THIS SUBDIVISION.

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Said Council hereby finds that that certain map surveyed by NORRIS E. LUEDTKE, Registered Civil Engineer, and entitled, "EMERALD RIVIERA Being a subdivision of the easterly one-half of the southwest quarter of Lot 29, Horton's Purchase, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 283 filed in the office of the County Recorder of San Diego County, March 9, 1878, excepting therefrom the west 30 feet thereof.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the streets and portion of street, to wit: Lace Place, Carolina Place and a portion of Carolina Lane, for public purposes, and said streets and portion of street are hereby declared to be public streets and portion of public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council rejects as a dedication for public street those portions of Lots A and B marked "Reserved for Future Street" as shown on this map, under the provisions of Section 11616 of the Business and Professions Code.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said

public streets and portion of public street are accepted on behalf of the public as heretofore stated; and said Council has rejected on behalf of the public those portions of Lots A and B marked "Reserved for Future Street" shown on this map within this subdivision, all as above stated.

Said City Clerk is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
