

RESOLUTION NO. 199370

WHEREAS, Princess Park Estates, Incorporated, located at 2030 State Street, San Diego, California, constructed an Offsite Water Main in connection with the development of the subdivision known as Princess Del Sol; and

WHEREAS, said main was oversized and constructed as a 12" line in order to accommodate and serve Fortune Park Units 8 and 9, developed by J. R. Shattuck Construction Company; and


WHEREAS, the J. R. Shattuck Construction Company has been required to pay and has paid to The City of San Diego the sum of \$1,968.00 as its share of oversizing a total of 320 lineal feet of said water main; and

WHEREAS, said sum should be paid over to Princess Park Estates, Inc.; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that at the recommendation of the Utilities Director and the City Manager, the City Treasurer be authorized to pay said amount of \$1,968.00 out of Fund No. 500 to Princess Park Estates, Incorporated.
