BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$987,912.40 by R. E. Hazard Contracting Co., A Corporation, for IMPROVEMENT OF FRIARS ROAD AND SEA WORLD DRIVE, BASE BID WITH ALTERNATE A AND B including ADDITIVE ALTERNATE #1 in the City of San Diego, California is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in the form on file in the office of the City Clerk as Document No. 730422.

2. That the expenditure of \$1,072,000.00 is hereby authorized out of the Gas Tax Fund 219 and supplementing Resolution 195364 in this amount; \$26,000.00 from Water Revenue Fund 502 and \$22,500.00 from Park and Recreation Bond Fund 725 of the City of San Diego solely and exclusively for the purpose of providing funds for IMPROVEMENT OF FRIARS ROAD AND SEA WORLD DRIVE, BASE BID WITH ALTERNATE A AND B including ADDITIVE ALTERNATE #1 in the City of San Diego, and related costs.
