That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, Utilities Agreement No. 15177 with the STATE DIVISION OF HIGHWAYS for relocation of sewer facilities on State Road 11-SD-805, 6.4-9.5 between 2.5 miles South and 0.6 miles North of Route 54 in the Sweetwater Valley to accommodate freeway construction, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 731394.
