

RESOLUTION NO. 199400

WHEREAS, the Board of Trustees of the California State Colleges have adopted a Master Plan for San Diego State College, as revised in 1967, which provides for an enrollment of 20,000 full-time equivalent students in day classes and a total of 10,000 parking spaces on campus when the campus is fully developed; and

WHEREAS, this number of spaces may fall short of requirements inasmuch as it is based on a ratio of only one parking space for each two full-time equivalent students; and

WHEREAS, a survey conducted by The City of San Diego shows that there are serious problems of congestion due to the parking of students' cars on streets in the vicinity of San Diego State College; and

WHEREAS, students at San Diego State College are charged a fee for the use of campus parking, which fee many students are unable or unwilling to pay; and

WHEREAS, residents in the area adjacent to San Diego State College are seriously inconvenienced by street parking by students with resulting detriment to persons working or living in the area and to property values in the area; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

This Council urges the Board of Trustees of the California State Colleges to establish a program for parking at San Diego State College which will insure that adequate spaces are provided on campus for all faculty, staff, students and visitors.

This Council urges the Board of Trustees of the California State Colleges to establish a program of fees for parking on campus at San Diego State College and take such other steps as

it deems necessary to insure that such parking is used by all faculty, staff, students and visitors.
