

RESOLUTION NO. 199401

WHEREAS, the Board of Trustees of the California State Colleges have adopted a Master Plan for San Diego State College, as revised in 1967; and

WHEREAS, it appears certain that enrollment in the fall semester of 1973 will exceed the maximum enrollment of 20,000 full-time equivalent students in day classes projected in this plan; and

WHEREAS, an enrollment in excess of 20,000 full-time equivalent students will produce intolerable traffic and parking problems in the San Diego State College area to the detriment of persons working and living in the area and to property values in the area;
NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

This Council urges the Board of Trustees of the California State Colleges and the Coordinating Council for Higher Education to maintain a firm limit of 20,000 full-time equivalent students at San Diego State College.
