

RESOLUTION NO. 199402

WHEREAS, by Resolution No. 194285 dated July 23, 1968 the Council of The City of San Diego established a priority list for certain underground conversion projects for communication and electrical facilities for the calendar year 1968; and

WHEREAS, by Resolution No. 197868 certain additional projects for the calendar year 1969 were established; and

WHEREAS, it would now appear that certain additional projects are feasible; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the priority lists established by the aforementioned resolutions be supplemented by the addition of the following projects for calendar year 1970:

1. Skyline Drive, south side between Bowie Street and Cardiff Street.
2. Imperial Avenue, north and south sides between Ozark Street and the east line of Euclid Avenue.

BE IT FURTHER RESOLVED, that this resolution is not adopted as an exercise of the police power of the City to compel relocation underground of overhead electrical facilities at the utility company's expense as set forth in City Ordinance No. 8183 of November 23, 1920.

BE IT FURTHER RESOLVED, that the establishment of the priority of projects as set forth above shall not be construed to preclude the City Council from exercising its police power to compel relocation underground of overhead electrical facilities at the utility company's expense if the general health, safety and welfare of the community should so require.
