WHEREAS, this Council intends to call a special election to be held on June 2, 1970, for the purpose of submitting to the voters of the City two propositions as set forth in this resolution amending the Charter of The City of San Diego; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. The Board of Supervisors of the County of San Diego is hereby requested to consolidate the special municipal election to be held for the purpose of amending the Charter of The City of San Diego in the City of San Diego on June 2, 1970, with the Statewide Primary Election to be held on the same date.

- The City Clerk is hereby directed to file a certified copy of this resolution with the Board of Supervisors and the Registrar of Voters of the County of San Diego.
