

RESOLUTION NO. 199409

WHEREAS, in connection with the filing of the subdivision to be known as PLAZA DE SAN YSIDRO UNIT NO. 2, Tentative Map No. 69-55, the developer thereof, SAN VICENTE INVESTMENTS, INC., a California corporation by Rick Engineering Company, has applied to the Council for a waiver of the underground electrical and telephone line requirements of Section 102.0221, paragraph 7 of the San Diego Municipal Code; and

WHEREAS, the Council has determined to waive said underground electrical and telephone line requirements upon conditions and terms as set forth in the agreement on file in the office of the City Clerk as Document No. 732380; and

WHEREAS, the Council should authorize the City Manager to execute said agreement and provide for its recordation in the office of the Recorder of San Diego County; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. The City Manager be, and he is hereby authorized to execute, for and on behalf of The City of San Diego that certain agreement with San Vicente Investments, Inc., a California corporation, on file in the office of the City Clerk as Document No. 732380.

2. The City Clerk be, and he is hereby authorized and directed to record in the office of the Recorder of San Diego County this resolution and the aforementioned agreement with San Vicente Investments, Inc. affecting the subdivision to be known as PLAZA DE SAN YSIDRO UNIT NO. 2, located between Interstate 5 and San Ysidro Boulevard, westerly of Smythe Avenue, in the Interim A-1-1 and R-4 Zones and R-4 Zone (C-1A upon recordation of map).
