BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$167,251.00 by W. R. Connelly, An Individual, for IMPROVEMENT OF BERNARDO CENTER DRIVE WEST OF U.S. HIGHWAY 395, EAST OF WEST BERNARDO DRIVE in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in the form on file in the office of the City Clerk as Document No. 730316.

2. That the expenditure of \$154,200.00 is hereby authorized out of the Gas Tax Fund 220 and supplementing Resolution 197240 in this amount, and \$15,200.00 from Capital Outlay Fund 245 of the City of San Diego solely and exclusively for the purpose of providing funds for IMPROVEMENT OF BERNARDO CENTER DRIVE WEST OF U.S. HIGHWAY 395, EAST OF WEST BERNARDO DRIVE in the City of San Diego, and related costs.
