That the expenditure of \$13,300.00 is hereby authorized out of the Gas Tax Fund (219) and that the expenditure of \$13,300.00 is hereby authorized out of the Sewer Bond Fund (728) of the City of San Diego solely and exclusively for the purpose of providing funds for IMPROVEMENT OF TORREY PINES ROAD BETWEEN PROSPECT PLACE AND ROSELAND DRIVE in the City of San Diego, and related costs.
