BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the expenditure of \$2,850 is hereby authorized out of Capital Outlay Fund 245 of The City of San Diego, solely and exclusively for the purpose of the installation of a traffic signal on Euclid Avenue easterly of Ridgeview Drive in the City of San Diego.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to do by City forces the necessary work for the installation of the above-described traffic signal, pursuant to recommendation of the City Manager and submission of estimates by him indicating that said work can be done by the City forces more economically than if let by contract.
