

RESOLUTION NO. 199434

WHEREAS, the Council of The City of San Diego designated a survey area for the project entitled "San Diego City College Expansion Project" by Resolution No. 196899 on May 13, 1969, pursuant to Section 33310 of the Community Redevelopment Law, Health and Safety Code of the State of California; and

WHEREAS, the Redevelopment Agency of The City of San Diego on April 29, 1969 by Resolution No. 10, designated a survey area for the project entitled San Diego City College Expansion Project; and

WHEREAS, a preliminary plan was prepared and approved by the Planning Commission of The City of San Diego for the San Diego City College Expansion Project pursuant to Section 33330 of the Health and Safety Code of the State of California by Resolution No. 71, on May 14, 1969; and

WHEREAS, it is now necessary for the Council and the Redevelopment Agency of The City of San Diego to hold a public hearing and adopt a redevelopment plan for the San Diego City College Expansion Project; and

WHEREAS, Section 33355 of the Health and Safety Code of the State of California provides that as an alternative to a separate public hearing, the Council of the City of San Diego may, with the consent of both bodies, hold a joint public hearing on the redevelopment plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Council of The City of San Diego does hereby consent to a joint public hearing as provided for by Sections 33355 through 33359 of the Health and Safety Code of the State of California.

2. That May 12, 1970 is designated as the date for the joint hearing by the Council and the Redevelopment Agency of The City of San Diego, said hearing to be held at 2:00 p.m. in the Council Chambers, 12th Floor, City Administration Building, Community Concourse, San Diego, California.
